1. I hereby certify that I have the authority to apply for credit on behalf of Applicant identified below and Applicants hereby authorize Huntin' Is Good!® (HIG) to investigate Applicants credit history, bank references, and any other sources of information deemed necessary to extend credit as allowed by the law.
2. All Sales are considered final. Returns, other than for defective product, are at the sole discretion of HIG and require an HIG Return Authorization Number (RAN). Should a return, for reasons other than defective product, be authorized, then HIG will be authorized to assess a 15% restocking fee; and revocation of any promotions, specials, or other offers redeemed because of original sale.
3. Applicant agrees to pay HIG invoices in accordance with the HIG terms of sale, which are net 30 days from date of invoice, unless otherwise specified in the HIG invoice.
4. Applicant will be responsible to pay HIG a service charge of 1.5% per month (18% per annual) or the highest rate permitted by law, on any unpaid balance due over thirty (30) days.
5. Applicant is responsible for all costs of collection including reasonable attorney's fees incurred by HIG in collecting any amounts due HIG by enforcing its rights.
6. Applicant gives a security interest to HIG in all products purchased from HIG to secure payment of any account balance owed HIG.
7. Applicant affirms that all information herein, together with all information submitted in connection with this application is true and accurate and that it will promptly notify HIG for any information changes.
8. Applicant agrees to immediately notify HIG for any shortages, price discrepancies, or freight disputes.
9. All new dealers are subject to a \$250 minimum prepaid first order.
10. A \$15.00 MINIMUM ORDER FEE will be added to all subsequent orders under \$250.00.
11. Credit Applicant(s) acknowledge that a service charge of \$30 will be applied to each check returned for insufficient funds.
